EARLY ENROLLMENT PROGRAM CONDITIONS OF ENROLLMENT

- The student must apply for admission to a full-time program offered by Johnson & Wales University.
- 2. The student must carry a course load as required of all full-time students enrolled in university degree programs.
- 3. The student is subject to all rules and regulations of the university that bind all full-time students, including class attendance, class schedules, payment of fees, etc.
- 4. The student must be interviewed at the university in the company of at least one parent or guardian before enrolling.
- 5. The student is responsible for any impact on high school graduation caused by early withdrawal from the university.
- 6. The university will forward reports of final grades to high school officials.
- 7. For the first year at JWU while enrolled in the Early Enrollment Program, the student is not eligible for federal financial aid, including Federal Work-Study, Federal Pell Grants and federal loans. However, the student WILL be eligible in the first year for JWU scholarships totaling up to 50 percent of any institutional aid they receive. For subsequent years, the student is eligible for all federal and JWU awarded funds.

- 8. The student must **submit a final official high school transcript** prior to entering their sophomore year at Johnson & Wales.
- The student will be unable to participate in class scheduling online until all high school graduation requirements are met.
- 10. If a student changes their major during the Early Enrollment Program/freshman year at the university, a new Early Enrollment Program agreement form may need to be submitted to the university. In addition, it is the student's responsibility to schedule a meeting with an academic advisor to review how the decision to change their major could impact their graduation date.
- 11. EEP students wishing to participate in college athletics at JWU likely cannot also participate in athletics at the high school they attend. Students most likely cannot compete in both.
