Johnson & Wales University offers \$5,000 academic scholarships, renewable for up to four years, to dependents* of Compass Group North America and Compass Group subsidiary employees who have been employed for more than one year. Up to 60 scholarship recipients will be chosen each academic year.

To be eligible, applicants must meet the following criteria:

- have an overall 3.0 GPA in high school academic classes
- be accepted and enrolled at JWU as an undergraduate, full-time day school student
- submit this application along with high school transcript and proof of parent's current employment with Compass Group

The deadline for scholarship applications is FEBRUARY 1.
