## JOHNSON & WALES UNIVERSITY / JWU RELEASE RELATED TO RECORDINGS

You (also referred to as Participant), for good and valuable consideration, including and in consideration of your participation in the activity, athletic game, competition, contest, interview, lecture, meeting, photo shoot, production, program, or any other event associated with the Recording (as the term is defined below), including the Recording itself, agree to the terms of this Release Related to Recordings (Release). By executing this Release, you are authorizing Johnson & Wales University (JWU) to record you and Use (as the term is defined below) the resulting Recordings (as the term is defined below) in the fashion outlined herein.

1. By signing this Release, you irrevocably give permission for and grant JWU the irrevocable right, to the maximum extent permitted by law, to:

  - c. This permission shall apply in whole or in part worldwide, without limitations or restrictions, in perpetuity.

To the maximum extent permitted by law, you agree to release JWU and its agents, directors, employees, officers, partners, trustees and board of trustees, and volunteers from any liability to you or anyone acting on your behalf, including your assigns, estate, executors, family, guardians, heirs, representatives, and successors, based upon or arising out of or related directly or indirectly to the Recordings or the Use of your image, likeness, name, photograph, voice, or writings. You understand JWU will hold the copyright in any such Recordings. You agree to make no accounting, monetary, or other claims against JWU for the Recordings or Use of your image, likeness, name, photograph, voice, or writings.
3. This Release Related to Recordings shall be governed in accordance with the laws of Rhode Island, without regard to choice-of-law or conflict-of-law principles.
